C. Green Campus

- ✓ To invest into the expansion of recycling opportunities on the College campus and transform waste into value added products.

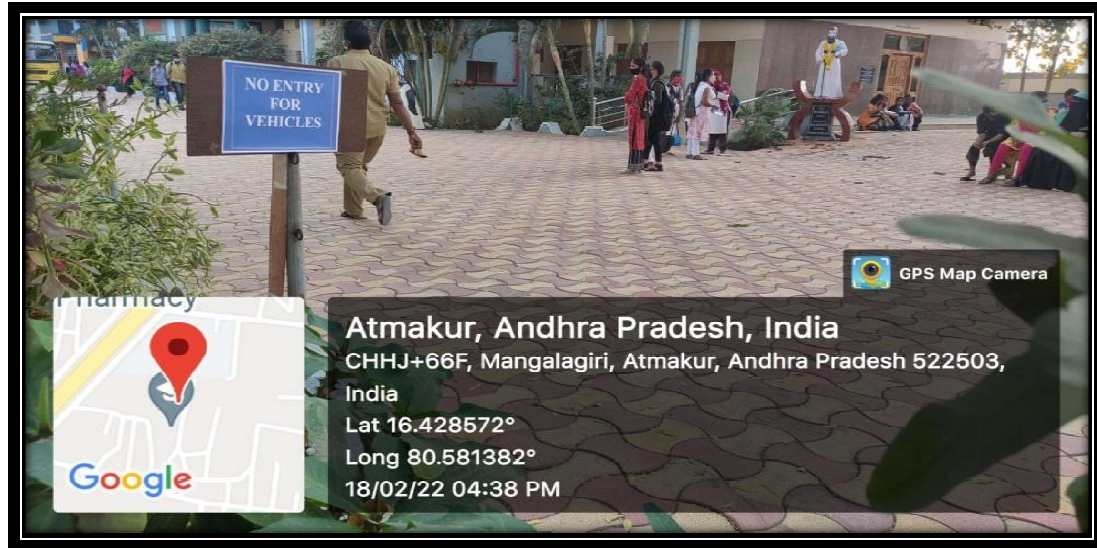
