As per the Disabilities act 1995 a person with disabled should have barrier free access to the education at all the levels of course. With this Aim and as per UGC guidelines our Nirmala college of pharmacy has got special facilities for the disable students, such as ramps, hand rails, audio visual tools, wheel chair and walking supporters like walker, hand sticks. Our institute also provides the guidance for the students with disability related to available facilities in the campus and financial support is also provided from various government and non government support.

Based on the admissions of the disabled students a committee will be framed for monitoring and guiding purpose of the Divyangjan throughout the course period with all the support till the process of employment.

So far no admissions were found under the disabled category; However, Our college is already equipped with the above facilities to the Divyangjan students and also to the elderly people who are accompanied with the admitted students.

- Connectivity corridor between the Nirmala block and Pasquali block will help for the easy access of the facilities in the campus.
- Signage board is available for identifying the facilities accessible in the campus at a glance.
- **Handrails** are also available which helps handicapped students to approach through the ramp.
- The college has wheelchair accessible toilets on the building with adequate space and also has hand rails.
